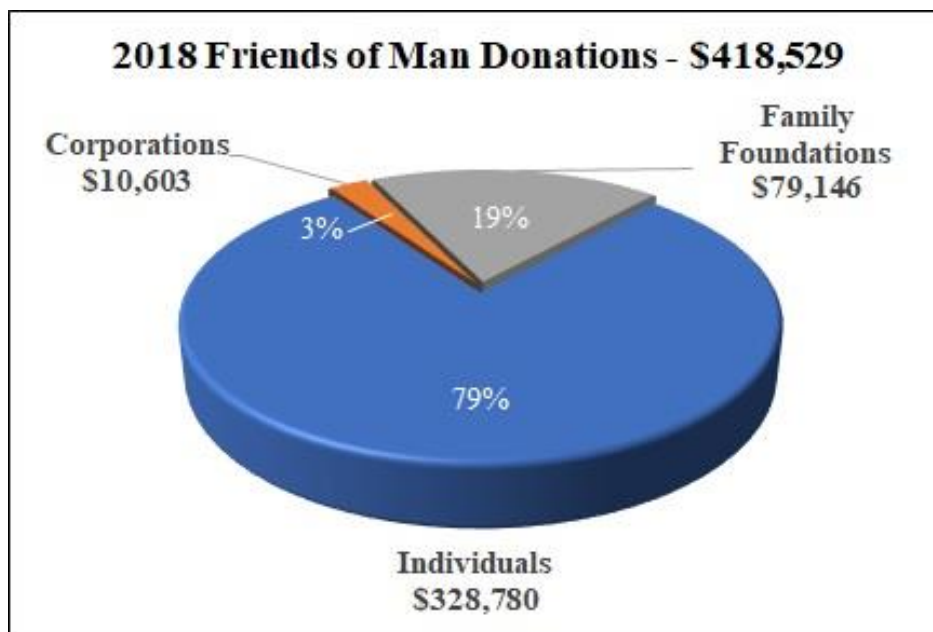


## FRIENDS OF MAN

**Every dollar that you contribute to Friends of Man goes 100% to help people in need!**

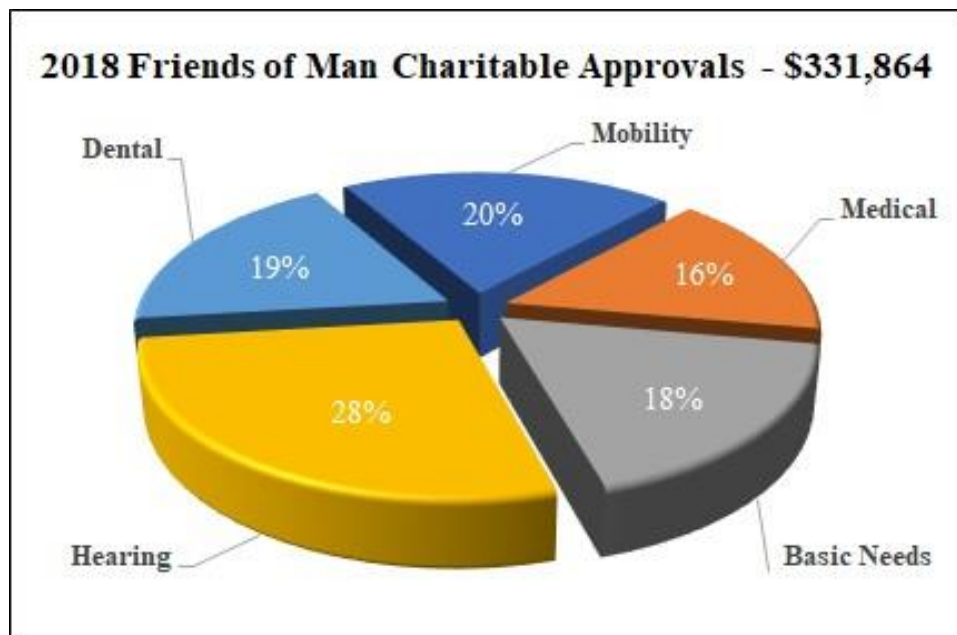

In 2018 Friends of Man had the honor of being selected by the *Single Parents Empowered Organization* to continue their work in the community. **The Single Parents Empowered Program of Friends of Man** received the transfer of SPE assets in the amount of **\$27,100**.

In addition, Friends of Man received two bequests totaling **\$187,000** which went into the **Bequest and Endowment Fund**



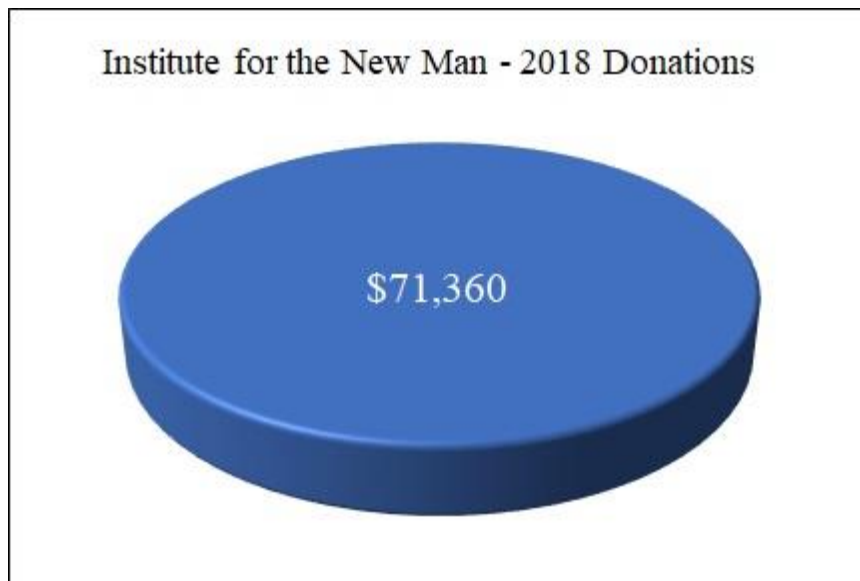

### **Institute for the New Man**

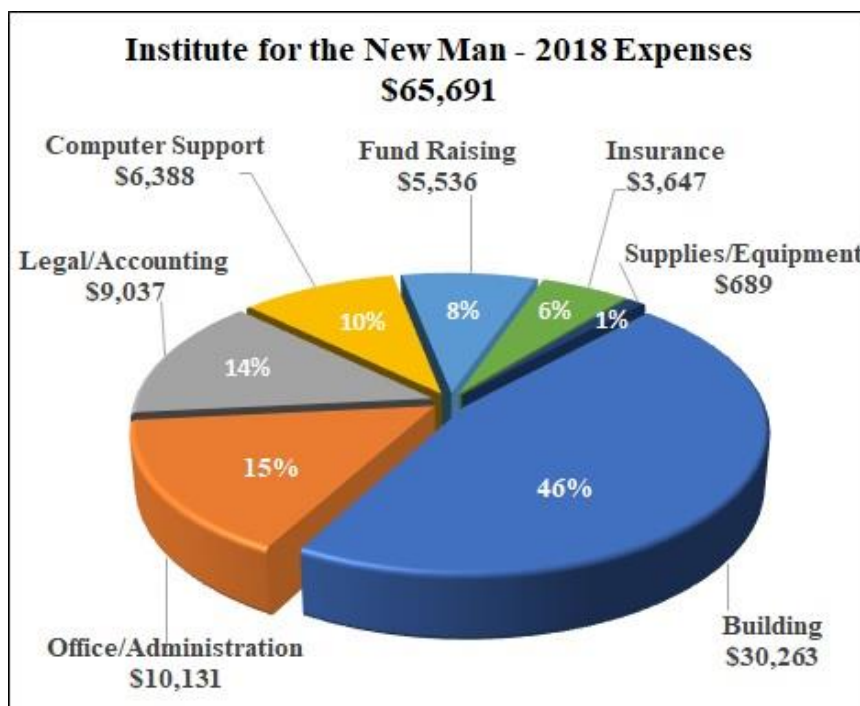
The Institute for the New Man (“IFNM”) is funded by donations from the core group of volunteers. These funds are used to pay all administrative costs and

expenses of operating Friends of Man. There NO SALARIES. The volunteers donate either time, skill, money – or all three. The funds of both IFNM and Friends of Man are strictly segregated and used only for their intended purposes. The annual independent audit of IFNM d/b/a FOM shows this segregation.
